- Tom WONI submitted the February report.
- Income was \$578.90, Expense was 314.98
- Budget Estimate Revision 2 categories (Annual & Budget).

Secretary:

Dennis KD6TUJ and Greg KI6RXX inquired about the lack of posting the PARC General & Board of Director Minutes to the website. It was explained about the recent difficulties experienced in using Dropbox as a means of sharing draft minutes for their approval by Board members prior to posting. The Board acknowledged the difficulties and would correct the process going forward by utilizing email for draft approval/corrections. The final copy with Board approval will be posted.

Dennis KD6TUJ and Greg KI6RXX also inquired about their removal from posting on the club's Facebook page. It was explained that too many complaints regarding their posts prompted Facebook to instruct the moderator to deal with the issue. So that was the action taken.

- Interfaith Emergency Preparedness Fair if we do this, we will need our signs, a 10x10 pop-up, table & volunteers.
- Facebook policies This was created for PARC members to discuss amateur radio and amateur radio topics. Unfortunately, 2 members' disruptive comments continued to garner enough negative comments that Facebook stepped in to ask the moderator to deal with the situation. The result was these 2 members have been removed from access.
- Bylaws Revision/Amendment The previous efforts to bring the by-laws up to date fell short. We need to review what we have. Joe K6JPE moved to dissolve the by-law committee, Glen KJ6ZQH second. Unanimous vote, Aye. Paul KB5MU will follow up with suggestions.
